DECLARATION BY THE CANDIDATE COUNTER SIGNED BY PARENTS/GUARDIAN

1. I declare that the entries made by me in this Admission Form are true in all respects and in case, any entry or information given is found to be false, this shall entail automatic cancellation of my admission besides rendering me liable to such action as the University may deem suitable.
2. I note that my admission in the University and my continuance on its rolls are subject to the provisions of the University and any other rules and instructions, which may be issued from time to time. I shall abide by the rules of discipline and conduct, which may be framed in this regard. I have fully understood the regulations and directions for banning ragging and affirm that I shall not indulge and involve myself in any act of ragging.
3. I also understand that, the fee mentioned is for 1st year only and may increase every year and that in case of withdrawal of admission by me after the last date of admission, it will be classified as a midcourse withdrawal and I shall be liable to pay the university fee for the whole course.
4. I have never been convicted by a court of law nor rusticated/expelled from any educational institution and nor disqualified/debarred from any examination.
5. All matters relating to differences among students and complaints of theft/ disputes/ fights/ quarrels shall be brought to the notice of the University authorities. No police complaint will be lodged by the student or parents without taking prior permission from the university authorities
6. Once admitted in the Hostel, I will compulsorily have to stay in the hostel for a minimum period of one academic year (excluding vacations). If I choose to leave hostel, then complete one-year hostel fee will be charged from me and that there will be no exception to this rule.
7. I understand that any act of misconduct committed by me inside or outside the campus shall be construed as an act of violation of discipline of the University. Without prejudice to the generality of the foregoing provisions, violation of discipline, among other things, shall include.
 - (i) Disruption of teaching, student examination, research or administrative work, curricular or extra-curricular activity or residential life of the members of the University, including any attempt to prevent any member of the University or its staff from carrying on his or her work; and any act reasonably to cause such disruption.
 - (ii) Damaging or defacing University property or the property of members of the University or any other property inside or outside the University campus.
 - (iii) Engaging in any attempt of wrongful confinement of teachers, officers, employees and students of the University or camping inside or creating nuisance inside the boundaries of houses of teachers, officers and other members of the University.
 - (iv) Use of abusive and derogatory slogans or intimidatory language or incitement of hatred and violence or any act calculated to further the same.
 - (v) Eve teasing or disrespectful behavior to women or girl students.
 - (vi) An assault upon, or intimidation of or insulting behavior towards a teacher, officer, employee or student or any other person.
 - (vii) Causing or colluding in the unauthorized entry by me into the campus or in the unauthorized occupation of any portion of University premises, including hostels or halls of residence by me.
 - (viii) Getting enrolled in more than one programme of study simultaneously in violation of the University rules.
 - (ix) Committing forgery, tampering with or misuse of the University documents or records, identification cards etc.
 - (x) Furnishing false certificate or false information to any office under the control and jurisdiction of the University.
 - (xi) Consuming or possessing alcoholic drinks, dangerous drugs, tobacco or other intoxicants in the University premises.
 - (xii) Indulging in acts of gambling in the University premises and loitering.
 - (xiii) Possession or using any weapons such as bricks, stones, knives, lathis, iron chains, iron rods, sticks, explosives, fire arms and acid in the University premises.

- (xiv) Arousing communal, caste or regional feelings or creating disharmony among students.
- (xv) Not disclosing identity, or not showing University identity card, when asked to do so by an employee or officer of the University who is authorized to do so.
- (xvi) Tearing of pages, defacing, burning and destroying of books of any library, seminar or answer sheets of examination.
- (xvii) Unauthorized occupation of hostel rooms or unauthorized acquisition or use of University furniture in one's hostel room or elsewhere.
- (xviii) Accommodating guests or other persons in hostels without permission of the Provost or Warden.
- (xix) Improper rendering of accounts for money drawn from or through any office under the control and jurisdiction of the University.
- (xx) Any act of moral turpitude.
- (xxi) Any offence under Law.
- (xxii) Committing any of the offences specified in the examination (Control of Unfair Means and Disorderly Conduct) regulations of the University.
- (xxiii) Violation of the Traffic Rules as notified by the Proctor/authorized person.
- (xxiv) Improper behavior while on tour or excursion.
- (xxv) Pasting of posters or distributing pamphlets, handbills etc. of an objectionable nature or writing on walls and disfiguring buildings.
- (xxvi) Disobeying the teachers and displaying misdemeanor within and outside the University premises, and/or not wearing prescribed uniform/aprons/laboratory coats/safety glasses etc.
- (xxvii) Indulging in vandalism/violence and damaging University and /or Public property or property of any other person
- (xxviii) Demonstrations, inciting protests, distributing hand bills etc.
- (xxix) Unauthorized use of mobile phone within the campus.
- (xxx) Any type of harassment whether physical, verbal, mental, sexual or electronic.
- (xxxii) Quarrelling, fighting and passing derogatory remarks inside/outside of University premises against fellow students/Teachers/employees/canteen and mess workers etc.
- (xxxii) Any other act which may be considered by the Vice Chancellor or the Discipline Committee to be an act of violation of Discipline.

NOTE In case of any default/misconduct on the part of the student in respect of the above, the University may take disciplinary action against him/her in this regard.

- 8. Starex University is committed to treating every employee/ student with dignity and respect. We seek to create an environment that is free from sexual harassment of any kind, whether verbal, physical or visual. All complaints of sexual discrimination or harassment will be treated in a serious manner and as per the act by the "Sexual Harassment committee"
- 9. Attendance of students in classes is mandatory. A student having attendance less than 75% will not be permitted to appear in the university examination. Attendance list of students will be displayed on notice board after every three months and parents will be informed.
- 10. I allow university authorities to take my ward to nearby hospitals in case of medical emergency. I shall be obliged to pay all medical expenses including transport charges incurred during treatment of my ward.

NOTE The students have to deposit fee due in respect of each semester by the date as prescribed by the University failing which the defaulters shall be liable to action as deemed appropriate by the University.
